Dear Mr. Dunagan:

I refer to our letter dated November 1, 2018 regarding the release of certain Department of State material under the Freedom of Information Act (the "FOIA"), 5 U.S.C. § 552. The processing of records is ongoing and has, thus far, yielded an additional 35 records responsive to your request. After reviewing these documents, we have determined that 10 may be released in full, 17 may be released in part, and 8 must be withheld in full.

All non-exempt material that is reasonably segregable from exempt material has been released in the enclosed pages. An enclosure explains the FOIA exemptions and other grounds for withholding material. Where we have made excisions, the applicable FOIA exemptions are marked on each document. In some cases, two or more exemptions may apply to the same document. The documents that were withheld in full were withheld under FOIA Exemptions 1 and 5, 5 U.S.C. §§ 552(b)(1) and (b)(5).


