# Situation Report – 188

Data as received by WHO from national authorities by 10:00 CEST, 26 July 2020

# Highlights

WHO has published an interim guidance on <u>safe Eid al Adha practices in the context of COVID-19</u>. The document highlights public health advice for social gatherings and religious practices that can be applied across different national contexts.

In Lao People's Democratic Republic, <u>Monks and health officials are working together to keep communities</u> <u>safe from COVID-19</u>. The Ministry of Health, Lao Front for National Development and the Central Buddhist Fellowship, with technical support from the WHO Regional Office for the Western Pacific and financial support from the United States via USAID, organized a two-day engagement event to discuss community level action to prevent COVID-19 and combat the fear, stigma and discrimination outbreaks can bring.

WHO has published a <u>draft landscape of COVID-19 candidate vaccines</u>. As of 24 July, twenty-five candidate vaccines are under clinical evaluation.

On 23 July, the WHO Regional Office for Africa warned of the threat posed by COVID-19 to health workers across Africa. <u>More than 10 000 health workers in the 40 countries are reported to be infected with COVID-19</u>, a sign of the challenges medical staff on the frontlines of the outbreak face.





#### **Case definitions**

WHO periodically updates the <u>Global Surveillance for human infection with coronavirus disease (COVID-19)</u> document which includes surveillance definitions.

#### **Definition of COVID-19 death**

A COVID-19 death is defined for surveillance purposes as a death resulting from a clinically compatible illness in a probable or confirmed COVID-19 case, unless there is a clear alternative cause of death that cannot be related to COVID-19 disease (e.g. trauma). There should be no period of complete recovery between the illness and death.

#### Annex 1: Data, table and figure notes

Caution must be taken when interpreting all data presented. Differences are to be expected between information products published by WHO, national public health authorities, and other sources using different inclusion criteria and different data cut-off times. While steps are taken to ensure accuracy and reliability, all data are subject to continuous verification and change. Case detection, definitions, testing strategies, reporting practice, and lag times differ between countries/territories/areas. These factors, amongst others, influence the counts presented, with variable underestimation of true case and death counts, and variable delays to reflecting these data at global level.

The designations employed, and the presentation of these materials do not imply the expression of any opinion whatsoever on the part of WHO concerning the legal status of any country, territory or area or of its authorities, or concerning the delimitation of its frontiers or boundaries. Dotted and dashed lines on maps represent approximate border lines for which there may not yet be full agreement. Countries, territories and areas are arranged under the administering WHO region.

\*A small number of countries/territories/areas report combined probable and laboratory-confirmed cases; efforts are underway to identify these for notation in the data table.<sup>+</sup>Other: includes cases reported from international conveyances.

Due to the recent trend of countries conducting data reconciliation exercises which remove large numbers of cases or deaths from their total counts, WHO will now display such data as negative numbers in the "new cases" / "new deaths" columns as appropriate. This will aid readers in identifying when such adjustments occur. When additional details become available that allow the subtractions to be suitably apportioned to previous days, graphics will be updated accordingly. Prior situation reports will not be edited; see <u>covid19.who.int</u> for the most up-to-date data.

#### Additional table notes

<sup>i</sup> Transmission classification is based on a process of country/territory/area self-reporting. Classifications are reviewed on a weekly basis and may be revised as new information becomes available. Differing degrees of transmission may be present within countries/territories/areas; classification is based on the highest category reported within a country/territory/area. Categories:

- No cases: with no confirmed cases;
- Sporadic cases: with one or more cases, imported or locally detected;
- Clusters of cases: experiencing cases, clustered in time, geographic location and/or by common exposures;

- Community transmission: experiencing larger outbreaks of local transmission defined through an
  assessment of factors including, but not limited to: large numbers of cases not linkable to transmission
  chains; large numbers of cases from sentinel lab surveillance; and/or multiple unrelated clusters in
  several areas of the country/territory/area;
- Pending: transmission classification has not been reported to WHO.

ii "Territories" include territories, areas, overseas dependencies and other jurisdictions of similar status.
